Regulatory information notices

The Australian Energy Regulator issues determinations to network entities that regulate the amount of income these entities can earn. To monitor outcomes against current determinations, and to prepare for future determinations, it uses regulatory information notices (RIN).

In 2018–19, the Australian Energy Regulator issued notices to Energex and Ergon for the current 2015–20 regulatory period (annual RIN) and the future 2020–25 regulatory period (reset RIN). Both types of notices collect financial and non-financial information from the distribution and transmission entities each year.

For each notice, Energex and Ergon completed a set of templates along with a basis of preparation, which is a document describing how each template has been prepared. These notices are subject to an audit (if the information is based on actual data) or a review (if the information is based on estimated data).
